RAMMOHAN COLLEGE will be registered as a Centre for learning of "COMMUNICATION SKILL IN ENGLISH / CAREER ENHANCEMENT SKILL PROGRAM/ SOFT SKILL PROGRAM".

A.BACKGROUND AND PURPOSE

WE FOR ALL has designed a communication skill development course/ Career Enhancement Skill Program /Soft Skill Program in English for Undergraduate Students and also the course is affiliated with them.

The course will be conducted by **WE FOR ALL**, the students have to get registered with **WE FOR ALL** , and on successful completion of the course, the assessment will be done by **WE FOR ALL** and accordingly Certificate will be issued to them.

Along with this soft skills, life skills, and preparation for the interview will be done.

B.OBJECTIVES

This agreement is for the collaborating efforts of both parties for the implementation of a skill development course/ Career Enhancement Skill Program /Soft Skill Program in English

1. The entry students shall be from the 1st Semester and the course duration would be a minimum period of 30 Hrs or Multiple of 30 Hrs.' for the period of three/four academic years.
2. There will be no limit to the intake of the students:

C.ACTION POINTS

1. RMC WILL

- I. Will identify at least students for the course based on the admission test.
- II. Ensure the class hours are adjusted to accommodate Multiple 30 hrs of classroom Training
- III. Assist WFA with any requirement as required to ensure smooth implementation of the course.

2. WFA

- I. Prepare content to be designed for career enhancement and submit a course schedule to RMC.
- II. Ensure well-trained trainers for the institute to ensure the overall success of the project.
- III. Monitor the program by conducting periodic assessments to ensure that the trainers do a quality job.

D.DURATION TERMS OF THE MoU

1. The MOU will be valid for three(3) years from the date of signing and may be extended from time to time in writing by the parties.
2. The memorandum of understanding is a document of good faith and implementation of the MoU would be monitored every quarter...

E.CHANGES/AMENDMENT

1. No change can be made to this MoU without written consent and duly signed by all the parties' addition, deletion, and /or alterations to this MoU may be effected with the written agreement of all the parties to this MoU concerning the changes.
2. Documents containing such additions, and deletions. And/or alterations and signed by all parties shall form addenda to this MoU and be deemed to be part of the MoU.

Neither party shall be liable to the other for failure or delay in the performance of any of its obligations under this MoU for the time and the extent such failure or delay is caused due to acts of god, natural disaster, fire, floods, explosions or earthquake, epidemic or quarantine restrictions, serious accidents, war, insurrection of riots, strikes, explosions or labor troubles, or any other cause beyond the affected party's reasonable control provided that sufficient notice of such occurrence of force majeure is communicated to the other party.
