The undersigned Parties to this Agreement have agreed to enter into a joint venture to provide quality education and training facilities and to share the resources and facilities of both the Parties.
PURPOSE OF THE AGREEMENT AND SCOPE OF THE AGREEMENT
The Parties have agreed to jointly establish and maintain a joint venture for the purpose of providing quality education and training facilities to the students of the Parties.
The joint venture shall be established and maintained for a period of five years from the date of signing of this Agreement, unless extended in writing by the Parties.

Article 1
OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MoU) is to cooperate with each other in educational projects in areas of mutual interest.

Article 2
SCOPE OF COOPERATION

The Parties agree to implement cooperative programmes including but not limited to:

1. Exchange of best practices regarding teaching learning process of both the institutions.
2. Collaborative Work on Conservation of eco system
3. Collaborative Work on Aquatic system towards sustainability
4. Faculty and student exchanges.
5. Experiential learning and research activities using heritage site of Raja Rammohun Roy Memorial Museum
6. Skill based certification/ add on certification courses.
7. Organizing seminars/webinars/conferences/symposia, etc.
8. Access of students of both institutions to quality enhancement programmes organized at both the institutions.
9. Undertaking Joint Research Programmes where possible.
10. Publication of Books containing Academic Papers/ Research Articles and / or special issues with ISBN.
11. Academic and Administrative Audit (AAA).
12. Any other academic and Administrative Activities.

Article 3
FINANCIAL ARRANGEMENT

Any cooperation under this MoU is subject to the availability of funding sources and approval of the relevant authorities.

Article 4
LOCATION OF ACTIVITIES

The parties agree to implement the programmes stated in Article 2 at Women's College, Calcutta, Kolkata and Rammohan College, Kolkata.
Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5
MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted both on Online/ Offline mode. Ample arrangements should also be made to conduct programmes in the Blended mode if required.

Article 6
DURATION AND TERMINATION

1. This MoU shall enter into force on the date of signing.
2. The MoU shall remain in force for five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
3. Either Party may terminate this MoU, at least twelve (12) months prior to the date of the termination.
4. The termination of this MoU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.
